

The MWP system is strategically located in the Rocky Mountains near large reserves of natural gas in six major producing areas, including the Greater Green River, Uinta and Piceance basins. MWP transports gas from these areas to other major pipeline systems for delivery to markets in the West and Midwest, including the Enbridge UT local distribution system.
